(iii) For any other Government which is a party to the Principal Agreement, the present Protocol shall come into force on the date of the deposit of its instrument of ratification or notification of accession.

(iv) The Government of the United Kingdom will inform the other Governments of the date on which the Protocol comes into force and the date of any ratification or accession received subsequently.

#### Article 11.

(i) The present Protocol shall be open to accession by any Government which has not signed it and which accedes to the Principal Agreement before the definitive entry into force of the Protocol.

(ii) Accession shall be effected by means of a notification in writing addressed to the Government of the United Kingdom and shall take effect immediately after the date of its receipt.

(iii) The Government of the United Kingdom will inform all the Governments which have signed or acceded to the present Protocol of all accessions received and the date of their receipt.

#### Article 12.

Any ratification of or the Principal Agreement which may be deposited or notified after the date of definitive coming into force of the present Protocol shall be deemed to relate to the Principal Agreement as amended by the present Protocol.

In witness whereof the undersigned, duly authorised thereto, have signed the present Protocol.

Done in London the twenty-fourth day of June, 1938, in a single copy, which shall be deposited in the archives of the Government of the United Kingdom of Great Britain and Northern Ireland by whom certified copies shall be communicated to all the signatory Governments.

III. For enhver anden Regering, som er Deltager i Hovedoverenskomsten, skal nærværende Protokol træde i Kraft den Dag, da dens Ratifikationsdokument deponeres eller Meddelelse om dens Tiltrædelse afgives.

IV. Det Forenede Kongeriges Regering vil underrette de andre Regeringer om Datoen for Protokollens Ikrafttræden og Datoen for enhver Ratifikation eller Tiltrædelse, som derefter modtages.

#### Artikel 11.

I. Nærværende Protokol kan tiltrædes af enhver Regering, som ikke har undertegnet den, og som tiltræder Hovedoverenskomsten før Protokollen er traadt endelig i Kraft.

II. Tiltrædelse sker ved en skriftlig Meddelelse til Det Forenede Kongeriges Regering og faar Virkning fra Datoen for dens Modtagelse.

III. Det Forenede Kongeriges Regering vil underrette alle Regeringer, som har underskrevet eller tiltraadt nærværende Protokol om alle modtagne Tiltrædelser samt Datoen for deres Modtagelse.

#### Artikel 12.

Enhver Ratifikation eller Tiltrædelse af Hovedoverenskomsten, som deponeres eller meddeles efter nærværende Protokols endelige Ikrafttræden, skal betragtes som havende Henblik paa Hovedoverenskomsten, saaledes som ændret ved nærværende Protokol.

Til Bekræftelse heraf har de undertegnede, dertil behørigt bemyndigede, underskrevet nærværende Protokol.
