

Section 2. *Adjustment of quotas*

The Fund shall at intervals of five years review, and if it deems it appropriate propose an adjustment of, the quotas of the members. It may also, if it thinks fit, consider at any other time the adjustment of any particular quota at the request of the member concerned. A four-fifths majority of the total voting power shall be required for any change in quotas and no quota shall be changed without the consent of the member concerned.

Section 3. *Subscriptions: time, place, and form of payment*

(a) The subscription of each member shall be equal to its quota and shall be paid in full to the Fund at the appropriate depository on or before the date when the member becomes eligible under Article XX, Section 4 (c) or (d), to buy currencies from the Fund.

(b) Each member shall pay in gold, as a minimum, the smaller of

- (i) twenty-five percent of its quota; or
- (ii) ten percent of its net official holdings of gold and United States dollars as at the date when the Fund notifies members under Article XX, Section 4 (a) that it will shortly be in a position to begin exchange transactions.

Each member shall furnish to the Fund the data necessary to determine its net official holdings of gold and United States dollars.

(c) Each member shall pay the balance of its quota in its own currency.

(d) If the net official holdings of gold and United States dollars of any member as at the date referred to in (b) (ii) above are not ascertainable because its territories have been occupied by the enemy, the Fund shall fix an

Afsnit 2. *Regulering af Kvoter.*

Fonden skal hvert femte Aar gennemgaa Medlemmernes Kvoter og, dersom den anser det for formaalstjenligt, fremsætte Forslag om en Regulering af disse. Den kan endvidere, dersom den finder det paakrævet, til ethvert andet Tidspunkt efter Anmodning fra det paagældende Medlem tage en Regulering af en individuel Kvota under Overvejelse. Til en Ændring i Kvoterne kræves $\frac{4}{5}$ Majoritet af det samlede Stemmetail, og ingen Kvota kan ændres uden vedkommende Medlems Samtykke.

Afsnit 3. *Indskud: Tid, Sted og Form for Indbetaling.*

a. Hvert Medlems Indskud skal være lig med dets Kvota og indbetales til Fonden med det fulde Beløb paa det behørig Indbetalingssted senest den Dato, da det paagældende Medlem i Henhold til Artikel XX, Afsnit 4, Punkt c eller d, bliver berettiget til at afkøbe Fonden Valuta.

b. Hvert Medlem skal som et Minimum i Guld indbetale det mindste af nedenstaaende Beløb:

1. 25 pCt. af sin Kvota; eller
2. 10 pCt. af sin officielle Nettobeholdning af Guld og U.S.A.-Dollars paa det Tidspunkt, da Fonden i Henhold til Artikel XX, Afsnit 4, Punkt a, meddeler Medlemmerne, at den i Løbet af kort Tid vil være i Stand til at paabegynde sine Valutaforretninger.

Hvert Medlem skal tilstille Fonden de til Fastsættelse af dets officielle Nettobeholdninger af Guld og U.S.A.-Dollars nødvendige Oplysninger.

c. Hvert Medlem skal indbetale Restsaldoen af sin Kvota i sin egen Valuta.

d. Dersom et Medlems officielle Nettobeholdninger af Guld og U.S.A.-Dollars paa det under Punkt b, 2, anførte Tidspunkt ikke kan fastslaaes, fordi dens Landomraader har været besat af Fjenden, fastsætter Fonden et andet passen-
