

2. Each Member nation shall, upon its acceptance of this Constitution, pay as its first contribution its proportion of the annual budget for the current financial year.

3. The financial year of the Organization shall be July 1 to June 30 unless the Conference should otherwise determine.

Article XIX

(WITHDRAWAL)

Any Member nation may give notice of withdrawal from the Organization at any time after the expiration of four years from the date of its acceptance of this Constitution. Such notice shall take effect one year after the date of its communication to the Director-General of the Organization subject to the Member nation's having at that time paid its annual contribution for each year of its membership including the financial year following the date of such notice.

Article XX

(AMENDMENT OF CONSTITUTION)

1. Amendments to this Constitution involving new obligations for Member nations shall require the approval of the Conference by a vote concurred in by a two-thirds majority of all the members of the Conference and shall take effect on acceptance by two thirds of the Member nations for each Member nation accepting the amendment and thereafter for each remaining Member nation on acceptance by it.

2. Other amendments shall take effect on adoption by the Conference by a vote concurred in by a two-thirds majority of all the members of the Conference.

2. Ved sin Tiltrædelse af disse Statutter yder enhver Medlemsstat som sit første Bidrag sin Andel af det aarlige Budget for det løbende Finansaar.

3. Organisationens Finansaar løber fra 1. Juli til 30. Juni, medmindre Konferencen træffer anden Bestemmelse.

Artikel XIX

(Udmeldelse).

Enhver Medlemsstat kan til enhver Tid efter Udløbet af 4 Aar fra Tiltrædelsesdatoen opgive sit Medlemskab af Organisationen. Saadan Opsigelse træder i Kraft et Aar efter, at den er blevet meddelt Organisationens Generaldirektør under Forudsætning af, at Medlemsstaten paa det paagældende Tidspunkt har betalt sit aarlige Bidrag for samtlige Aar, den har været Medlem, herunder det efter Opsigelsesdatoen følgende Finansaar.

Artikel XX

(Ændringer i Statutterne).

1. Saadanne Ændringer i nærværende Statutter, som medfører nye Forpligtelser for Medlemsstaterne, kræver Vedtagelse af Konferencen ved en Afstemning, ved hvilken to Trediedele af samtlige Konferencens Medlemmer stemmer herfor, og træder i Kraft med Virkning for de Medlemsstater, der har tiltraadt Ændringen, fra det Tidspunkt at regne, da to Trediedele af Medlemsstaterne har tiltraadt den, og derefter for de øvrige Medlemsstater, naar disse tiltræder Ændringen.

2. Andre Ændringer træder i Kraft, naar de vedtages af Konferencen ved en Afstemning, hvor to Trediedele af samtlige Konferencens Medlemmer stemmer herfor.
