

financial statement of the Organization. The Assembly shall approve the accounts and the budget.

(b) The Assembly shall apportion the expenditures of the Organization among the Members, in accordance with a scale of contributions to be fixed by the Assembly, and each Member shall contribute promptly to the Organization its share of these expenditures.

(c) If a Member is in arrears in the payment of its contributions by an amount which equals or exceeds the amount of contributions due from it in respect of the preceding two completed financial years, the Member shall have no vote, and shall not be counted in the determining of the fulfilment of the relevant voting requirements, in the organs of the Organization. If the Assembly is satisfied that the failure to pay is due to circumstances beyond the control of the Member, it may, nevertheless, permit such a Member to vote, and then such Member shall be counted accordingly.

Article 10—Status.

(a) The Organization shall have legal personality.

(b) The Organization shall enjoy in the territory of each of the Members such legal capacity, privileges and immunities as may be necessary for the exercise of its functions.

(c) The representatives of the Members, and the officials of the Organization shall similarly enjoy such privileges and immunities as may be necessary for the independent exercise of their functions in connexion with the Organization.

(d) The privileges and immunities to be accorded by a Member to the Organization, to its officials and to the representatives of its Members shall be similar to those accorded by that Member to specialized agencies of the United Nations, to their officials and to the representatives of their members, under the Convention on the Privileges and Immunities of the Specialized Agencies, or under similar arrangements.

b) Forsamlingen skal fordele Organisationens udgifter mellem Medlemmerne i overensstemmelse med en af Forsamlingen fastsat bidragsskala, og hvert Medlem skal uden forsinkelse yde sit bidrag til Organisationens til dækning af sin andel af disse udgifter.

c) Såfremt et Medlem er i restance med betalingen af sine bidrag med et beløb, som er lige så stort som eller overstiger det bidragsbeløb, som Medlemmet er pligtigt at betale for de to forudgående, afsluttede finansår, er Medlemmet ikke stemmeberettiget i Organisationens organer og skal ikke medregnes ved afgørelsen af, om de i betragtning kommende regler for afstemning i disse organer er opfyldt. Såfremt det over for Forsamlingen godtgøres, at undladelsen af at betale skyldes omstændigheder, hvorover Medlemmet ikke har herredømme, kan den dog tillade, at Medlemmet afgiver stemme, og et sådant Medlem skal da tilsvarende medregnes ved de ovennævnte afgørelser.

Artikel 10 — Retsstilling.

a) Organisationen skal betragtes som en juridisk person.

b) Organisationen skal indenfor ethvert Medlems territorium have en sådan juridisk handleevne og nyde sådanne privilegier og immuniteter, som måtte være nødvendige for udøvelsen af dens funktioner.

c) Medlemmernes repræsentanter og Organisationens embedsmænd skal ligeledes nyde sådanne privilegier og immuniteter, som måtte være nødvendige for den uafhængige udførelse af deres funktioner vedrørende Organisationen.

d) De privilegier og immuniteter, som et Medlem indrømmer Organisationen, dennes embedsmænd og dens Medlemmers repræsentanter skal svare til dem, som dette Medlem indrømmer De Forenede Nationers særlige institutioner, disses embedsmænd og deres medlemmers repræsentanter i henhold til Konventionen om de særlige Institutioners Rettigheder og Immuniteter eller i henhold til lignende ordninger.
