Article 15.

1. Panel members shall serve for renewable periods of six years.

2. In case of death or resignation of a member of a Panel, the authority which designated the member shall have the right to designate another person to serve for the remainder of that member's term.

3. Panel members shall continue in office until their successors have been designated.

Article 16.

1. A person may serve on both Panels.

2. If a person shall have been designated to serve on the same Panel by more than one Contracting State, or by one or more Contracting States and the Chairman, he shall be deemed to have been designated by the authority which first designated him or, if one such authority is the State of which he is a national, by that State.

3. All designations shall be notified to the Secretary-General and shall take effect from the date on which the notification is received.

Section 5.

Financing the Centre.

Article 17.

If the expenditure of the Centre cannot be met out of charges for the use of its facilities, or out of other receipts, the excess shall be borne by Contracting States which are members of the Bank in proportion to their respective subscriptions to the capital stock of the Bank, and by Contracting States which are not members of the Bank in accordance with rules adopted by the Administrative Council.

Section 6.

Status, Immunities and Privileges.

Article 18.

The Centre shall have full international legal personality. The legal capacity of the Centre shall include the capacity

Artikel 15.

1. Medlemmerne udpeges for seks år; de kan genudpeges.

2. Når et listemedlem afgår ved døden eller træder tilbage, har den myndighed som udpegede ham, ret til at udpege en anden person, som skal fungere i den resterende del af perioden.

3. Listemedlemmer skal forblive i deres embede, indtil en afløser er udpeget.

Artikel 16.

1. En person kan optages på begge lister.

2. Når en person er udpeget til optagelse på samme liste af mere end én kontraherende stat eller af én eller flere kontraherende stater og formanden, skal han anses for udpeget af den myndighed, som først udpegede ham eller, såfremt en af de nævnte myndigheder er den stat i hvilken han er statsborger, da af denne.

3. Ethvert udpegning skal meddeles til generalsekretæren og har virkning fra den dato, meddelelsen er modtaget.

Afsnit 5.

Centrets finansiering.

Artikel 17.

Såfremt centrets udgifter ikke kan dækkes gennem gebyrer for benyttelsen af dets faciliteter eller gennem andre indtægter, skal det overstigende beløb bæres af de kontraherende stater, som er medlemmer af banken, i forhold til deres respektive tegningsandele i bankens kapital, og af de kontraherende stater, som ikke er medlemmer af banken, i overensstemmelse med regler godkendt af det administrative råd.

Afsnit 6.

Status, immuniteter og privilegier.

Artikel 18.

Centret skal have fuld international retsevne. Dets retlige handleevne skal indbefatte ret til
