**MEMORANDUM OF AGREEMENT ON
BASIC ELEMENTS FOR THE
NEGOTIATION OF A WORLD GRAINS
ARRANGEMENT**

The Governments of Argentina, Australia, Canada, Denmark, Finland, Japan, Norway, Sweden, Switzerland, the United Kingdom, the United States, and the European Economic Community and its member States

HAVE AGREED as follows:

Article 1

Each signatory to this Agreement agrees to negotiate a world grains arrangement, on as wide a basis as possible, in a conference promptly called for such purpose, that contains the provisions set forth in Article 2, to work diligently for the early conclusion of the negotiation, and upon completion of the negotiation to seek acceptance of the arrangement in accordance with its constitutional procedures as rapidly as possible.

Article 2

**Principal Items of World Grains

I. Pricing provisions

1. The Schedule of minimum and maximum prices, basis f.o.b. Gulf ports, is established for the duration of this arrangement as follows:

**OVERENSKOMST OM GRUNDLAGET
FOR FORHANDLING OM EN
INTERNATIONAL KORNORDNING**

Regeringerne i Argentina, Australien, Canada, Danmark, Finland, Japan, Norge, Svejts, Sverige, Storbritannien, USA og Det europæiske økonomiske Fællesskab og dets medlemslande

ER blevet enige om følgende:

Artikel 1

Ethvert land, som har undertegnet denne aftale, erklærer sig rede til på en konference, som snarest indkaldes med nedennævnte formål, at deltage i forhandlinger om en international kornordning på det bredest mulige grundlag, indeholdende de i artikel 2 anførte bestemmelser, at medvirke aktivt til en snarlig afslutning af forhandlingerne og derpå at søge denne ordning tiltrådt snarest muligt i overensstemmelse med sin forfatningsmæssige praksis.

Artikel 2
