

Government of the State concerned, and the third arbitrator, unless the parties otherwise agree, shall be appointed by such other authority as may have been prescribed by regulations adopted by the Board of Governors. The third arbitrator shall have full power to settle all questions of procedure in any case where the parties are in disagreement with respect thereto.

Chapter IX Final Provisions

Article 63. Signature and Deposit.

(1) This Agreement, deposited with the Secretary-General of the United Nations (hereinafter called the "Depositary"), shall remain open until 31 December 1963 for signature by the Governments of States whose names are set forth in Annex A to this Agreement.

(2) The Depositary shall communicate certified copies of this Agreement to all the Signatories.

Article 64. Ratification, Acceptance, Accession and Acquisition of Membership.

(1) (a) This Agreement shall be subject to ratification or acceptance by the Signatories. Instruments of ratification or acceptance shall be deposited by the Signatory Governments with the Depositary before 1 July 1965. The Depositary shall notify each deposit and the date thereof to the other Signatories.

(b) A State whose instrument of ratification or acceptance is deposited before the date on which this Agreement enters into force shall become a member of the Bank on that date. Any other Signatory which complies with the provisions of the preceding paragraph shall become a member on the date on which its instrument of ratification or acceptance is deposited.

(2) Regional States which do not acquire membership of the Bank in accordance with the provisions of paragraph 1. of this article may become members - after the Agreement has entered into force - by accession thereto on such terms as the Board of Governors

Kapitel IX Afsluttende bestemmelser

Artikel 63. Undertegnelse og deponering

(1) Denne overenskomst, hvis tekst deponeres hos De forenede Nationers Generalsekretær (i det følgende benævnt »depositaren«), skal indtil 31. december 1963 stå åben for undertegnelse af regeringerne for de i Tillæg A til denne overenskomst nævnte stater.

(2) Depositaren skal tilstille alle signatarstaterne bekræftede kopier af denne overenskomst.

Artikel 64. Ratifikation, godkendelse, tiltrædelse og opnåelse af medlemskab

(1) (a) Denne overenskomst skal kunne ratificeres eller godkendes af signatarstaterne. Ratifikations- eller godkendelsesinstrumenter skal deponeres af signatarregeringerne hos depositaren inden 1. juli 1965. Depositaren skal underrette de øvrige signatarstater om enhver deponering og datoen herfor.

(b) En stat, hvis ratifikations- eller godkendelsesinstrument deponeres før den dato, på hvilken denne overenskomst træder i kraft, bliver medlem af Banken fra den dato. Enhver anden signatarstat, som efterkommer bestemmelserne i det foregående punkt, bliver medlem fra den dato, på hvilken dens ratifikations- eller godkendelsesinstrument deponeres.

(2) Regionale stater, som ikke opnår medlemskab af Banken i henhold til bestemmelserne i denne artikels stk. 1, kan blive medlemmer efter at overenskomsten er trådt i kraft ved at tiltræde denne på vilkår, der fastsættes af repræsentantskabet. Regeringen
