*Part VI*

Article 23

Nothing in this Convention shall affect any provisions that are more conducive to the achievement of equality between men and women which may be contained:

- (a) In the legislation of a State Party; or
- (b) In any other international convention, treaty or agreement in force for that State.

Article 24

States Parties undertake to adopt all necessary measures at the national level aimed at achieving the full realization of the rights recognized in the present Convention.

Article 25

1. The present Convention shall be open for signature by all States.

2. The Secretary-General of the United Nations is designated as the depositary of the present Convention.

3. The present Convention is subject to ratification. Instruments of ratification shall be deposited with the Secretary-General of the United Nations.

4. The present Convention shall be open to accession by all States. Accession shall be effected by the deposit of an instrument of accession with the Secretary-General of the United Nations.

Article 26

1. A request for the revision of the present Convention may be made at any time by any State Party by means of a notification in writing addressed to the Secretary-General of the United Nations.

2. The General Assembly of the United Nations shall decide upon the steps, if any, to be taken in respect of such a request.

Article 27

1. The present Convention shall enter into

*Kapitel VI*

Artikel 23

Intet i denne konvention har indvirkning på nogen bestemmelse, som bidrager mere til opnåelse af ligestilling mellem mænd og kvinder, og som er indeholdt i

- a) en deltagende stats lovgivning eller
- b) i nogen anden international konvention, traktat eller aftale, der gælder for den pågældende stat.

Artikel 24

De deltagende stater påtager sig på nationalt plan at vedtage alle nødvendige forholdsregler, der tilsigter den fulde virkeliggørelse af de rettigheder, der anerkendes i denne konvention.

Artikel 25

1. Denne konvention står åben for under-tegnelse af alle stater.

2. De forenede Nationers generalsekretær er depositar for denne konvention.

3. Denne konvention skal ratificeres. Ratifikationsinstrumenterne skal deponeres hos De forenede Nationers generalsekretær.

4. Denne konvention står åben for tiltrædelse af alle stater. Tiltrædelse finder sted ved deponering af et tiltrædelsesinstrument hos De forenede Nationers generalsekretær.

Artikel 26

1. Anmodning om revision af denne konvention kan til enhver tid fremsættes af en deltagende stat ved skriftlig meddelelse til De forenede Nationers generalsekretær.

2. De forenede Nationers generalforsamling beslutter herefter, om der skal træffes foranstaltninger i anledning af en sådan anmodning og i givet fald hvilke.

Artikel 27

1. Denne konvention træder i kraft på den
