

force on the thirtieth day after the date of deposit with the Secretary-General of the United Nations of the twentieth instrument of ratification or accession.

2. For each State ratifying the present Convention or acceding to it after the deposit of the twentieth instrument of ratification or accession, the Convention shall enter into force on the thirtieth day after the date of the deposit of its own instrument of ratification or accession.

Article 28

1. The Secretary-General of the United Nations shall receive and circulate to all States the text reservations made by States at the time of ratification or accession.

2. A reservation incompatible with the object and purpose of the present Convention shall not be permitted.

3. Reservations may be withdrawn at any time by notification to this effect addressed to the Secretary-General of the United Nations, who shall then inform all States thereof. Such notification shall take effect on the date on which it is received.

Article 29

1. Any dispute between two or more States Parties concerning the interpretation or application of the present Convention which is not settled by negotiation shall, at the request of one them, be submitted to arbitration. If within six months from the date of the request for arbitration the parties are unable to agree on the organization of the arbitration, any one of those parties may refer the dispute to the International Court of Justice by request in conformity with the Statute of the Court.

2. Each State Party may at the time of signature or ratification of this Convention or accession thereto declare that it does not consider itself bound by paragraph 1 of this article. The other States Parties shall not be bound by that paragraph with respect to any State Party which has made such a reservation.

3. Any State Party which has made a reservation in accordance with paragraph 2 of this article may at any time withdraw that reservation by notification to the Secretary-General of the United Nations.

2. For enhver stat, der ratificerer eller tiltræder denne konvention efter deponeringen af det tyvende ratifikations- eller tiltrædelsesinstrument, træder konventionen i kraft på den tredivte dag efter datoen for deponeringen af dens eget ratifikations- eller tiltrædelsesinstrument.

Artikel 28

1. De forenede Nationers generalsekretær skal modtage og til alle stater rundsende teksten til forbehold, der tages af stater ved ratifikationen eller tiltrædelsen.

2. Et forbehold, der er uforeneligt med denne konventions hensigt og formål, er ikke tilladeligt.

3. Forbehold kan til enhver tid tilbagekaldes ved meddelelse herom til De forenede Nationers generalsekretær, som skal underrette alle stater herom. En sådan meddelelse får virkning fra datoen for dens modtagelse.

Artikel 29

1. Enhver tvist mellem to eller flere deltagende stater vedrørende fortolkningen eller anvendelsen af denne konvention, som ikke bilægges ved forhandling, skal på begæring af en af parterne overgives til voldgift. Hvis parterne ikke inden seks måneder fra datoen for begæringen om voldgift kan blive enige om foranstaltning af voldgift, kan enhver af disse parter henvise tvisten til Den internationale Domstol ved anmodning i overensstemmelse med domstolens statutter.

2. Enhver deltagende stat kan på tidspunktet for undertegnelse eller ratifikation af denne konvention eller ved tiltrædelse hertil erklære, at den ikke betragter sig bundet af denne artikels stk. 1. De andre deltagende stater er ikke bundet af denne artikels stk. 1 i forhold til nogen stat, som har taget et sådant forbehold.

3. Enhver deltagende stat, som har taget forbehold i overensstemmelse med denne artikels stk. 2, kan til enhver tid tilbagekalde dette forbehold ved meddelelse herom til De forenede Nationers generalsekretær.
