Article XVI

Until the date on which this Protocol enters into force in accordance with the provisions of Article XVIII, it shall remain open for signature by any State.

Article XVII

1. This protocol shall be subject to ratification by the signatory States.

2. Ratification of this Protocol by any State which is not a Party to the Warsaw Convention or by any State which is not a Party to the Warsaw Convention as amended at The Hague, 1955, shall have the effect of accession to the *Warsaw Convention as amended at The Hague, 1955, and by Protocol No. 4 of Montreal, 1975.*

3. The instruments of ratification shall be deposited with the Government of the Polish People's Republic.

Article XVIII

1. As soon as thirty signatory States have deposited their instruments of ratification of this Protocol, it shall come into force between them on the ninetieth day after the deposit of the thirtieth instrument of ratification. It shall come into force for each State ratifying thereafter on the ninetieth day after the deposit of its instrument of ratification.

2. As soon as this Protocol comes into force it shall be registered with the United Nations by the Government of the Polish People's Republic.

Article XIX

1. This Protocol, after it has come into force, shall be open for accession by any non-signatory State.

2. Accession to this Protocol by any State which is not a Party to the Warsaw Convention or by any State which is not a Party to the Warsaw Convention as amended at The Hague, 1955, shall have the effect of accession to the *Warsaw Convention as amended*

Artikel XVI

Indtil den dato, hvor denne protokol træder i kraft i overensstemmelse med bestemmelserne i artikel XVIII, skal den forblive åben for undertegnelse af enhver stat.

Artikel XVII

1. Denne protokol skal ratificeres af signarstaterne.

2. Ratifikation af denne protokol af nogen stat, der ikke er deltager i Warszawa-konventionen, eller af nogen stat, der ikke er deltager i Warszawa-konventionen, som ændret i Haag, 1955, skal have virkning som tiltrædelse af *Warszawa-konventionen, som ændret i Haag, 1955 og ved Montreal-protokol nr. 4, 1975.*

3. Ratifikationsinstrumenterne skal deponeres hos Folkerepublikken Polens regering.

Artikel XVIII

1. Så snart tredive signatarstater har deponeret deres ratifikationsinstrumenter vedrørende denne protokol, skal den træde i kraft imellem dem på den halvfemsindstyvende dag efter deponeringen af det tredivte ratifikationsinstrument. Den skal træde i kraft for hver stat, der derefter ratificerer den, på den halvfemsindstyvende dag efter deponeringen af dens ratifikationsinstrument.

2. Så snart denne protokol træder i kraft, skal den registreres hos de Forenede Nationer af Folkerepublikken Polens regering.

Artikel XIX

1. Denne protokol skal, efter at den er trådt i kraft, være åben for tiltrædelse af enhver ikke-signatarstat.

2. Tiltrædelse af denne protokol af nogen stat, der ikke er deltager i Warszawa-konventionen, eller af nogen stat, der ikke er deltager i Warszawa-konventionen, som ændret i Haag, 1955, skal have virkning som tiltrædelse af *Warszawa-konventionen, som ændret i*
