

shall be submitted to arbitration by a tribunal of three (3) arbitrators, one appointed by the Bank, another by the member or former member concerned, and the third, unless the parties otherwise agree, by the President of the International Court of Justice or such other authority as may have been prescribed by regulations adopted by the Board of Governors. A majority vote of the arbitrators shall be sufficient to reach a decision which shall be final and binding upon the parties. The third arbitrator shall have full power to settle all questions of procedure in any case where the parties are in disagreement with respect thereto.

Article 59

APPROVAL DEEMED GIVEN

Whenever the approval or the acceptance of any member is required before any act may be done by the Bank, except under Article 56 of this Agreement, approval or acceptance shall be deemed to have been given unless the member presents an objection within such reasonable period as the Bank may fix in notifying the member of the proposed act.

Chapter X

FINAL PROVISIONS

Article 60

SIGNATURE AND DEPOSIT

1. This Agreement, deposited with the Government of the French Republic (hereinafter called 'the Depository'), shall remain open until 31 December 1990 for signature by the prospective members whose names are set forth in Annex A to this Agreement.

2. The Depository shall communicate certified copies of this Agreement to all the Signatories.

lægges en voldgiftsret, bestående af tre voldgiftsmænd, én udnævnt af Banken, én af det berørte medlem eller det udtrådte medlem og én af præsidenten for Den Internationale Domstol eller sådan anden autoritet, som måtte være foreskrevet ved en af af Banken vedtaget bestemmelse, medmindre parterne kommer overens om en anden ordning. En flertalsafgørelse blandt voldgiftsmændene er tilstrækkelig til at nå en beslutning, som er endelig og bindende for parterne. Den tredje voldgiftsmand har fuld beføjelse til at afgøre ethvert procedurespørgsmål i tilfælde, hvor parterne ikke kan opnå enighed herom.

Artikel 59

Stiltiende godkendelse

I tilfælde hvor der kræves et medlems godkendelse eller accept, inden Banken kan foretage en handling, anses denne godkendelse eller accept, hvor intet andet er bestemt i artikel 56, for at være givet medmindre medlemmet fremkommer med en indsigelse inden for en passende frist, som fastsættes af Banken ved underretning af medlemmet om den foreslåede handling.

Kapitel X

Afsluttende bestemmelser

Artikel 60

Undertegnelse og deponering

1. Denne overenskomst, der er deponeret hos Den Franske Republiks regering (i det følgende benævnt »depositaren«) er åben for undertegnelse indtil den 31. december 1990 for potentielle medlemmer, hvis navne er anført i bilag A til denne overenskomst.

2. Bekræftede kopier af denne overenskomst tilstilles alle signatarerne.
